Concept note

The unique characteristics of European small-sized States, including their territory size, population, and systems of statehood, have attracted the special attention of constitutional and international law theorists and practitioners. The distinctiveness of these States offers a fertile ground for exploring the nuances of constitutionalism beyond the usual paradigms applicable to larger States.

Recognizing the importance and the unique challenges arising in this context, this international conference is designed to provide a forum for discussion between scholars, legal practitioners, and representatives from European small-sized States on the aspects of constitutionalism in small-sized European States.

The Venice Commission has analysed in opinions some important elements concerning the functioning of small-sized States, such as the separation of powers, and the design and functioning of State institutions, including the judicial systems. The first panel of the conference will further explore the constitutional aspects and challenges faced by European small-sized States. Special attention will be given to the electoral processes and their specifics in the context of the small-sized States.

The second panel will focus on the interaction between European small-sized States and Council of Europe monitoring and expert bodies. Representatives of GRECO, MONEYVAL, and CEPEJ will present their perspectives and experiences. The discussion will revolve around previous interaction and lessons learned, aiming to highlight good practices and areas for improvement in the governance and monitoring systems within the small-sized States.

The third panel will be dedicated to the implementation of the Council of Europe standards of judicial independence in small-sized States. It will provide reflections on the practical challenges and achievements in introducing and implementing judicial reforms aimed at safeguarding the independence and impartiality of judicial institutions in small-sized States. The role of superior courts in ensuring judicial independence will be an important point of discussion, highlighting their crucial role within the European small-sized State framework.
