PROGRAMME

Background

The international high-level conference titled "Respect for the Decisions of Constitutional Courts" aims to underscore the paramount importance of constitutional court decisions in safeguarding the rule of law and human rights across national and international jurisdictions. The conference will convene constitutional court judges, liaison officers, Venice Commission members, and representatives from the Council of Europe to engage in an in-depth dialogue on how decisions of constitutional courts shall be respected by the public and different branches of power and how constitutional courts can effectively bridge national legal systems with international human rights frameworks. In an era where human rights are continually evolving, the role of constitutional courts becomes indispensable in interpreting and implementing these rights within the national context. The keynote address and subsequent panel discussions will explore the profound influence of constitutional court decisions on national legal orders, the fostering of trans-judicial dialogues, and the reconciliation of conflicts between national and international legal systems.

One of the key highlights of the conference is the examination of how constitutional court decisions act as a nexus between national and international human rights legal orders. The first panel will address the crucial role these courts play in the implementation of the European Convention on Human Rights and other treaties, emphasising the European yardsticks for human rights standards. Participants will delve into the complexities of how constitutional court decisions and those of the European Court of Human Rights can shift from obstruction to collaboration through effective trans-judicial dialogue. The second panel will scrutinise the respect and modes of implementation of constitutional court decisions across Europe, shedding light on the delicate balance between political respect and compulsory enforcement of these decisions. The third panel will focus on the constitutional review in the context of the Rule of Law checklist of the Venice Commission and the practice of national jurisdictions in its effective application. The final panel will tackle the impact of media and social media on the perception and criticism of constitutional court decisions, exploring the limits of judicial freedom of expression and the challenges posed by other branches of power and public opinion.

The Venice Commission plays a pivotal role in this context by promoting cooperation among constitutional courts. This collaboration not only enhances the efficacy of constitutional courts but also strengthens the overall framework of democratic governance and human rights protection. The insights garnered from this conference will contribute to a deeper understanding of the challenges and opportunities faced by constitutional courts, ultimately fortifying the rule of law and human rights across diverse jurisdictions.
